

Dear Mr. Geoffino,

According to New York State Education Law as it pertains to the Board of Education of the City School District of New Rochelle: a member of the Board appointed to an unexpired term shall serve until the next Annual District Meeting (School Board Election) on the third Tuesday in May. At the Annual District Meeting, the candidate receiving the highest number of votes will get the 5-year term, the candidate receiving the second highest number of votes will get the second highest unexpired term (i.e. 3-year term), and the candidate receiving the third highest number of votes will get the third highest unexpired term (i.e. 2-year term), and so forth. It may happen that a newcomer candidate may receive the 5-year term and the incumbent may be elected to serve the lowest or one of the lowest terms. The incumbent, whose term expires on June 30, 2015, will serve until that date, but the members elected for the unexpired terms may be seated and serve immediately upon filing the oath of office. The oath of office must be filed within 30 days of the commencement of the term.

You may seek additional advice from your counsel, if necessary.

It is my understanding that the term for George K. Walters, N.R. Public Library Trustee, will expire on June 30, 2015. Is that correct? I will follow up with you as we get closer to the Annual District Meeting.

First, let me say that I find the conduct here to be despicable. Hanna told the board BEFORE the May election that she was moving out of New Rochelle and yet she held off resigning until the summer. How many times over the last 10 years has a library board seat been filled by popular election, what was the date, who won the seat?

In the past I have been supportive of the library. I am no longer inclined to support a tax-payer funded entity that is run by a board that treats its obligation to be an elected body as a nuisance to be skirted rather than a sacred trust which is what it is.

Please provide answers to the questions above.
