HOW WE GOT HERE: PROJECT HISTORY

2020

Facility Conditions Study

An independent assessment found major building systems - roof, HVAC, electrical, plumbing - were at or past their useful life. The study identified critical needs: replace failing systems, add fire sprinklers to the 3rd floor, and make the building fully ADA accessible.

2021

Strategic Plan Adopted

The Library's Board of Trustees adopted a Strategic Plan with a clear facilities goal: "Enhance the Library's facility so that it is best-in-class and built for the future." This established community-driven direction for the capital project.

2025

Cost Estimating & Bond Scoping

Professional cost estimators developed a detailed project scope and preliminary cost estimates.

2026

Community Vote — May 19, 2026

Registered voters in the New Rochelle school district will decide whether to authorize the \$55M bond. Polls open May 19, 2026.

This bond is the result of years of careful study, planning, and community engagement — not a rushed decision.

WHY THIS BOND IS NEEDED NOW

The New Rochelle Public Library building is aging and many core systems are reaching the end of their useful life.



Aging Roof & Systems

Core building systems require replacement; delays will drive costs higher.



Infrastructure Upgrades

HVAC, electrical, and plumbing systems need modernization for reliability.



Accessibility & ADA

Improvements required to ensure full access for all community members.



Outdated Public Spaces

Library spaces no longer meet how the community uses the Library today.

Making these investments now protects the building, improves safety, and modernizes spaces responsibly.

WHAT THE BOND WILL FUND



BOND FUNDS WILL BE USED FOR:

- Roof replacement and building envelope repairs
- HVAC, electrical, plumbing, and infrastructure upgrades
- Accessibility and ADA improvements
- Renovation of Children's, Teen, and Adult library spaces
- Study rooms, practice pods, and flexible programming areas
- Furniture, fixtures, and equipment related to renovations
- Professional services: architectural, engineering, and construction management

WILL NOT BE USED FOR:

- Library salaries or daily operating expenses
- Programs unrelated to building improvements
- Projects outside the voter-approved scope

COMMUNITY IMPACT:

- Spaces for students, families & adult learners
- Phased construction — Library stays open
- Supports growing demand for programs

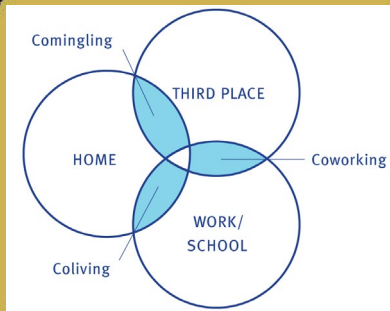

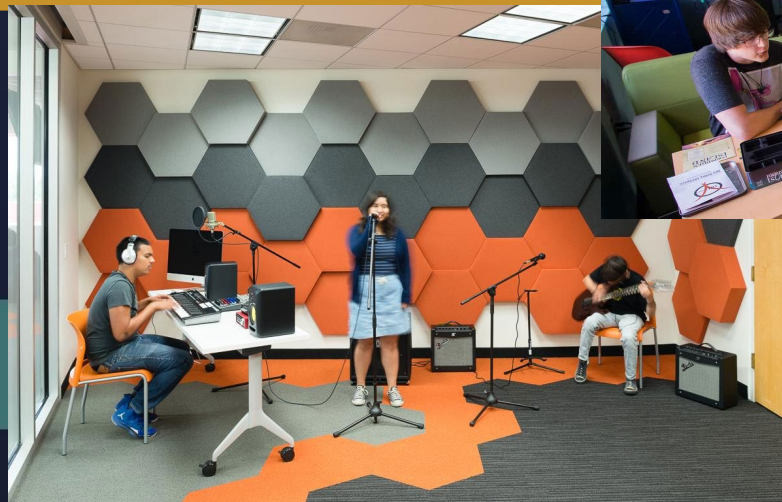

WHAT HAPPENS IF THE BOND PASSES



1

Community Engagement

Resident input gathered to confirm priorities and shape the project.

2

Architectural & Engineering Design

Professional teams complete detailed plans and specifications.

3

Final Cost Estimates & Bidding

Competitive bidding ensures value; costs are finalized.

4

Bond Issuance — 2028 at Earliest

Bonds will not be issued before 2028. No taxpayer cost goes into effect until this step.

5

Phased Construction & Public Oversight

Work completed in phases; Library stays open. Regular public updates and board oversight throughout.

Bond funds may only be used for the specific purposes authorized by voters on May 19, 2026.

Board of Trustees Oversight



Spending is overseen by the Library Board of Trustees, a publicly accountable governing body.

Public Audit & Reporting



All funds are subject to independent public audit and transparent financial reporting.

Capped Amount & Tax Impact



The bond amount and resulting tax impact are capped at the amount approved by voters.
